A motion was made by Member Judy Newton to approve the August 20<sup>th</sup> Minutes. Vice Chair Bill Drumwright seconded the motion.

**REPORT FROM COUNCIL LIAISON**

**Mayor Jeff Rasco relayed that all Board and Committee Members must submit in writing to City Staff as to whether they would like to stay on their respective board or**

**committee or leave before December 2025. Any new persons can submit an application for any open spots by December.**

**Also, landscape companies need contacting by a member of the Board. City Manager is waiting on recommendations to contact and present to council.**

**Mayor Rasco relayed information on regular outdoor music concerts at the Triangle. The Trees and Parks Board would collaborate with Community Relations Committee on a variety of musical acts and genres.**

**Mayor Rasco also relayed that council brought forward a Resolution to create a parkland fund. Once all bills are paid, 3% of unallocated funds will continue to accrue to be used towards acquiring or improving parks and greenspace.**

**Lastly, the Watershed Association is possibly hosting a working, educational workshop on November 8<sup>th</sup>, 2025 at Triangle Park. Workshop includes ways to conserve water and native planting around Gazebo.**

**REGULAR AGENDA:**

**1. Discussion and Possible Action Regarding Beautification Of The Rainwater Tank By Gazebo At Triangle Park.**

A Motion was made by Member Linda Swedberg that the water tank in Triangle Park be painted a sage green with the option of adding the Woodcreek Parks Logo at any time. Member Judy Newton seconded the motion.

Motion passed 4-1-0

**2. Discussion and Take Appropriate action on Moving Forward With New Tree Planting At Brookmeadow And Shady Grove, Per Council's Recommendation.**

A Motion was made by Chairperson Jacob McElroy to direct City Staff to acquire a Mexican Sycamore Tree to plant at Brookmeadow and Shady Grove.

Member Linda Swedberg Seconded the Motion.

**3. Workshop for Tree Giveaway.**

Details on where to purchase trees, raffle items, food, educational speakers, donations and moving the giveaway to a new location was discussed.
