BUDGET HEARING NOTICE

FISCAL YEAR 2020-2021

The City of Woodcreek, Texas, will hold a public hearing at the following day and time for the purpose of receiving written or oral comments concerning the proposed budget for Fiscal Year 2020-2021. In accordance with the order of the Office of the Governor issued March 16, 2020, the City Council of the City of Woodcreek, Texas will conduct a video and telephonic meeting in order to advance the public health goal of limiting face-to-face meetings (also called “social distancing”) to slow the spread of COVID-19.

Time: 2:00 PM

This budget will raise more revenue from property taxes than last year’s budget by an amount of \$22,382.00, which is an 4.32% increase from last year’s budget. The property tax revenue to be raised from new property added to the tax roll this year is \$4,382.00.






