6 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODCREEK,**
7 **TEXAS (“CITY”), SETTING A PUBLIC HEARING ON THE APPLICATION**
8 **TO CHANGE RATES FROM AQUA WATER, INC. AND TO DETERMINE**
9 **THE PROPRIETY OF SAME**

12 WHEREAS the City Council has determined there are ongoing concerns regarding the
13 the Application dated June 18, 2025 to Change Rates received from Aqua
14 Water, Inc. (“Application”); and

16 WHEREAS the City Council previously decided and took action to suspend the
17 effective date of the changed rates 90 days from July 25, 2025 to October
18 23, 2025 and began a hearing process to determine the propriety of the
19 Application changed rates requested pursuant to Texas Water Code
20 13.187(f); and

22 WHEREAS the City Council finds the need to set a public hearing date to determine
23 the propriety of said Application and to consider the impacts on the
24 health, safety, and welfare of the Woodcreek community.

26 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**
27 **WOODCREEK, THAT:**

31 The City Council of the City of Woodcreek will set a public hearing to determine the propriety
32 of the Aqua Water, Inc. Application to Change Rates and to consider the impacts on the health,
33 safety, and welfare of the Woodcreek community on November 17, 2025 at 6:00 p.m. to be held
34 at VFW Post #6441, 401 Jacobs Well Rd, Wimberley, TX.

38 The City Council directs City Staff to post said public hearing pursuant to the Texas Open
39 Meetings Act and send all necessary notices, including providing notice to Applicant Aqua
40 Water, Inc. and the community.

44 The City Secretary is instructed to include a copy of this Resolution among the records of the
45 City.

49 The meeting at which this Resolution was passed was open to the public, and that public notice
50 of the time, place and purpose of said meeting was given as required by the Open Meetings Act,
