6 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODCREEK,**
7 **TEXAS (“CITY”), APPROVING A BUDGET AMENDMENT FOR FISCAL**
8 **YEAR 2026 TO TRANSFER \$5,000.00 FROM THE FUNDVIEW ACCOUNT (10-**
9 **10-5061) INTO THE GREEN BUILDING INITIATIVE LINE ITEM (10-10-5206)**
10 **FOR THE RAINWATER INCENTIVE PROGRAM AND FOR PURPOSE OF**
11 **PROMOTING SWIMMING POOL CONSERVATION THROUGHOUT AND**
12 **WITHIN THE CITY LIMITS**

14 WHEREAS the City Council has determined there are ongoing concerns regarding the
15 protection and preservation of water and conservation efforts within the
16 City of Woodcreek, Texas (“City”); and
17

18 WHEREAS water conservation provides essential ecological, environmental, and
19 health benefits that are integral to the well-being of residents in the city;
20 and

22 WHEREAS the City Council finds that additional funding of the City’s Rainwater
23 Incentive Program (“Program”) to promote swimming pool conservation
24 throughout and within the city limits is necessary for the health, safety,
25 and welfare of the Woodcreek community; and
26

27 WHEREAS a budget amendment to meet the needs of the Program for adequate
28 funding may be accomplished by the transfer of funds from the Fundview
29 Account to the City’s Green Building Initiative line item.

31 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**
32 **WOODCREEK, THAT:**

36 The above Recitals are true and correct and are a material part of this Resolution and are
37 incorporated herein for all purposes.

39 **II.**

41 The City Council does hereby approve the budget amendment for the Fiscal Year beginning
42 October 1, 2025, and ending September 30, 2026, to reflect a change in the budget with a
43 transfer of \$5,000.00 from the Fundview account (10-10-5061) into the Green Building Initiative
44 line item (10-10-5206) for the Rainwater Incentive Program and for purpose of promoting
45 swimming pool conservation throughout and within the city limits.

49 The City Council directs City Staff to implement the Rainwater Incentive Program with the
50 additional funding authorized starting October 1, 2025, for the 2026 Fiscal Year and future years
51 for the express purposes set forth herein.

55 The City Secretary is instructed to include a copy of this Resolution among the records of the
56 City.

60 The meeting at which this Resolution was passed was open to the public, and that public notice
61 of the time, place and purpose of said meeting was given as required by the Open Meetings Act,
62 Texas Government Code, Chapter 551.
