- 1. Call to Order: Mayor Eskelund called the meeting to order at 6:30 p.m.
- 2. Invocation

- 5. Public Comments: Terry Eldridge said she is against an adult retreat use of Camp Young Judaea because of traffic. Joe Kotarba asked the Council to review the regulations governing commercial operations in the City with regard to protection of the quality of life in Woodcreek. Jennifer Richmond is against any use of Camp Young Judaea beyond recreational activities. Sybil Patterson asked the Council to hold a meeting for all Brookhollow residents regarding the road project. Lou Joseph asked the City to enforce the codes regarding the use of the Camp to retain the residential character of the City. Lynn Joseph expressed concern about buses and large profile vehicles breaking tree branches, possibly exposing them to oak wilt. Anthony Antista said the City will lose its residential character if the camp is allowed to expand its use. Mike Schneider said not one citizen is in favor of expansion of the Camp.

- 7. Report Items:
