- 4. Approval of Minutes of March 20, 2019. Commissioner Boze moved to approve the minutes of March 20, 2019. The motion was seconded by Vice Chairperson Joe Kotarba and passed with a vote of 5-0-0.
- 5. Discussion and Take Possible Action on Proposed Regulations for Short-Term Rentals and a Possible Recommendation to City Council. The following citizen communications were received and noted:

Suzanne Gordon – in favor of proposed regulations; against allowing short term rentals in other residential areas

Beth & Jim McJunkin - in favor of regulations to protect the city from STR's

City Manager Lewis, Councilmember Cyndi Jackson and Councilmember Aurora F. LeBrun explained the process for developing the proposed regulations. After discussion, the Planning and Zoning Commission suggested the following changes to the proposed regulations:

Persons leasing must be over 21 years old and a person of that age must be on the property at all times.

No gunfire.

No pets except those allowed by the City of Woodcreek.

(f)(8) Parking needs further work. Also, advertising should be required to state how many parking spaces are available.

Rental regulations – define large parties. Change "unruly gathering" to "unruly behavior".

Fire prevention in application doesn't match regulations.

Application fee is too low.

Questioned authority of planning and zoning commission to approve applications.

Add that violations result in revoking permit.

Ask Fire Marshall for recommendations and if inspections should be required.

Needs consistency between documents and more specific expectations – ex. quiet hours.
